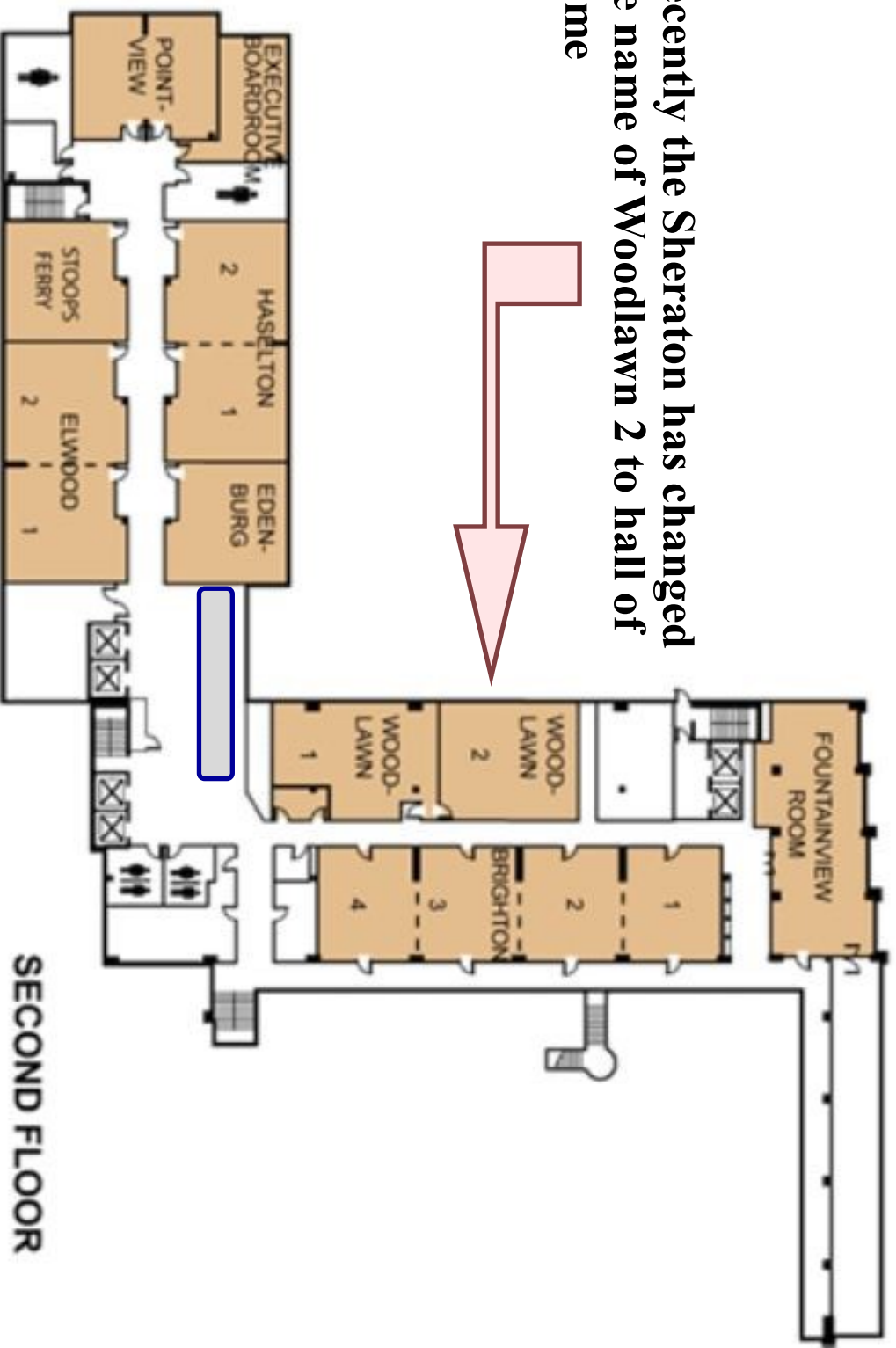
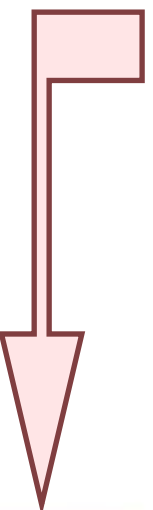

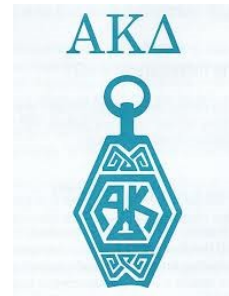

## Welcome to the North Central Sociological Association's 2018 Annual Meeting!

I have been to every NCSA conference for as long as I have been in the region, which is about 18 years. During those years, I have increasingly come to think of NCSA as my professional family. Our conferences are small enough to facilitate the development of close professional ties, but big enough to offer a vibrant and intellectually stimulating conference. I am especially happy that we so seamlessly accommodate a range of professional needs and interests, from cutting-edge research to classroom concerns to professional development.

The theme for this year's conference, *Crime, Punishment and In/Justice*, practically gave itself. At every turn of the criminal justice process fresh questions concerning justice arise: what kinds of people get punished, for what crimes, and how severely? Scholarship keeps demonstrating not only deep and pervasive inequities but also astounding contradictions in the law and its enforcement. Corporate elites can get away with stealing millions from employee retirement funds while the person who robs a corner store of a few hundred dollars can spend years in prison. "Quality of life" harassments (jay walking, spitting) entangle black and brown children in the criminal justice system whereas energy corporation get tax breaks for polluting and depleting the environment for future generations. While child abusers can operate, sometimes for decades, under the protection of powerful institutions, powerless children can get handcuffed and arrested for the smallest of infractions. In some communities, the presence of the police is a relief, in others it is a threat. We know that race and ethnicity matters, we know that class matters, and we know that gender matters. But so much more work needs to be done to not only reveal the full extent to which injustice pervades the law and criminal justice system, but also to understand how people respond, push back, and try to affect change.

One person who is already doing path-breaking work around such issues is Victor Rios, our John and Ruth Useem plenary speaker this year. His award-winning book, *Punished: Policing the Lives of Black and Latino Boys*, is simultaneously a deeply unsettling account of the relentless harassment and surveillance of black and brown boys and a homage to their determination to find dignity where others see only dead ends and futility. They know what is happening to them and have no trouble recognizing that all the criminal justice cards are stacked against them. And yet, they respond creatively, if not always in ways that the adult world finds productive. His book *Human Targets: Schools, Police, and the Criminalization of Latino Youth*, continues the story but now with a focus on the treacherous territory that links policing and education and that, far from providing a path out for so called troubled Latino boys, further ensnares them in a sometimes deadly game of charades, where everyone knows – teachers, policy officers, the kids themselves – that the purpose is not education but control. As you peruse the program you will find a number of sessions linked to the overall conference theme, ranging from crime and inequality to the classroom as a transformative space.

I want to thank the program committee – Rachel Stein (vice president and program chair), Mellisa Holtzman (research sessions), Tamika Odum (teaching sessions), and Alan McEvoy (undergraduate sessions) – for assembling such an exciting program, and Joyce Lucke, our conference coordinator, for doing all the largely invisible work behind the scene that makes the conference possible. Enjoy!

## **Name Badges Without Institutional Affiliation: Thinking about ‘Status’ with Sociological Disciplinary Associations**

In 2012, I was asked to serve as one of the co-chairs for the American Sociological Association Task Force on Community College Faculty. Ultimately, the task force developed and fielded the largest survey of faculty teaching sociology in community colleges that has ever been conducted. The Task Force published three articles based on analysis of the survey results in a special issue of *Teaching Sociology*, that was focused on community colleges. Over the years, many community college faculty have felt the effect of the ‘name badge’ phenomenon at sociology meetings (faculty from other types of teaching institutions have noted the same). What is this phenomenon? Many people in the ASA survey reported feeling that they were ‘looked down upon’ or viewed as ‘less than’ by faculty from four year institutions. Over the years, at various meetings and activities, community college participants also noted being treated differently when a colleague in a session or in elevators sees ‘community college’ on the name badge. Unfortunately, I have experienced this several times over the years, including the year I was awarded the ASA Outstanding Award to Teaching.

One recommendation of the Community College Task Force was to remove institutional affiliation from name badges at conferences. It is not that we viewed institutional affiliation as not important, but rather hoped that colleagues would at least engage in conversation with other colleagues during conferences without being hindered by preconceived notions of ability based on our institutional affiliation. Unfortunately, while other recommendations were unanimously approved by the American Sociological Association, this recommendation was not. As much as I understand the importance of institutional affiliation, I do think the hierarchical status systems of institutional affiliation within our discipline is problematic. Given our discipline, I strongly believe that we should strive to be inclusive of all members of our discipline.

I was able to share my concerns with the North Central Sociological Association last fall. I have found our association more amicable to welcoming all types of faculty and students. The NCSA embraces the importance of both teaching and scholarship. We reach out to community college faculty as well as graduate students. Thus, the 2018 Planning Committee made a decision to pilot removing institutional affiliation from the name badges this year. Unfortunately, due to a scheduling issue, I am not able to be in attendance to see the realization of the Community College Task Force’s idea!

It is my hope, and that of others in our association, that you will make time to go up and introduce yourself to as many colleagues as possible and take time to get to know them and to ask them about the institution where they work and to help everyone feel more included.

## **John F. Schnabel Distinguished Contribution to Teaching Award**

John F. Schnabel (1932-2005) served for a quarter of a century in the Sociology Department at University of West Virginia. He was a major advocate for teaching undergraduates, both within the ASA and within the NCSA.

John was an early leader in the ASA's early "Projects on Teaching" and in the Departmental Resources Group, conducting many workshops on innovative teaching. He was tireless in serving in various leadership roles and as a mentor to new faculty. John was instrumental in founding of the NCSA Teaching Committee and served as its first Chair from 1985 to 1988. Prior to the founding of that committee, annual NCSA meetings typically had one or two teaching sessions (out of more than a hundred sessions). By the end of his three-year tenure as Chair, there were eight. Under his tutelage, subsequent committee chairs worked to expand the teaching program, and by the early 1990s, the NCSA would annually list more than twenty teaching sessions.

The criteria and the process for the NCSA's Distinguished Contributions to Teaching Award were crafted by John himself. He held many leadership positions in the NCSA Council and was always a solid source of advice and counsel. He was a tireless worker who energized all who knew him.

## **Aida Tomeh Distinguished Service Award**

The Aida Tomeh Distinguished Service Award is an annual award recognizing a member of the NCSA who has given outstanding service to the NCSA, either through a single exceptional activity, or through different activities over an extended period of time, or throughout his/her professional career. The award is named after Aida Tomeh, who was a member of the faculty at Bowling Green State University from 1965 until her untimely death in 1984, following a long illness. Her undergraduate degree was from the American University in Beirut, and her PhD was from the University of Michigan (1962). Following Michigan, her faculty positions started at Bowling Green (1962), then Beirut University College (1963-1965), then back to Bowling Green, where she remained for the rest of her career.

She was a regular session organizer and presenter at professional meetings, on topics as far ranging as antique shopping to language maintenance among Arab Americans. Aida was especially committed to the NCSA, to which she devoted an extraordinary amount of time and energy. In addition to coordinating the mid-annual meetings of the Council which were always held in Bowling Green, she served as Executive Secretary (1974-1977), Council Member-at-Large (1977-1980), and Chair of the Development Committee (1980-1984).

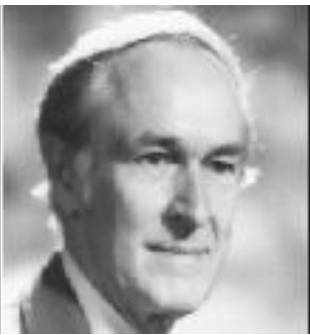

## **J. Milton Yinger Lifetime Award: Distinguished Career in Sociology**

The NCSA Lifelong Award for Distinguished Career is named after J. Milton Yinger.



During his career, Milt contributed to (1) sociological theory, (2) sociology of religion, (3) race and ethnic relations, and (4) sociology of countercultures. Each area where he did work, he left a legacy. Milt's "field theory" was one of the early attempts to move sociological theory toward a closer look at social process and at the dynamism of an organism within its complex environment. His book, *Toward a Field Theory of Behavior* was an important theoretical contribution in the early 1960s. His book *The Scientific Study of Religion* was the gold standard of texts in the sociology of religion, and he opened doors to new ways of conceptualizing and measuring the essence of religiosity. In the field of racial and ethnic relations, he and Oberlin colleague George Simpson were awarded the Anfield Wolf Award for best scholarly

work in 1958. The notion of "countercultures" is of specially interest, since he quite literally coined the concept. His American Sociological Review article in 1960 was reprinted in 15 anthologies and translated into many languages.

Milt was President of the NCSA and held several elected positions in the ASA. In fact, Milt is the only past President of NCAS to also was elected President of ASA. Further, Milt Yinger is the only person from any region of the country to be elected President of American Sociological Association while being employed at a teaching-oriented liberal arts college. He taught at Oberlin College from 1947 to 1987. In the fall of 2006, in his 90th year, he had an article translated and published in Chinese.



Milt Yinger was an academician par excellence, but he also believed in applied sociology. This is part of the wisdom of J. Milton Yinger:

*Can the scholar be content with identifying key problems and seeking to understand them? In my judgment, no. Values without knowledge are blind. Knowledge without values is empty. Both without policies are futile. That credo unites the diverse elements in my scholarly and social action efforts.*
