



Welcome to the 2023 Annual Meeting of the

North Central Sociological Association!

Welcome to Grand Rapids, where the rapids are, well, grander (I assume) than elsewhere in the state of Michigan. Come to think of it, the name of our host city derives from the Grand River right outside, so probably no evaluation of turbulent water was intended. But Grand Rapids is a wonderful place, as I hope all of you will discover while you are here.

It took the North Central Sociological Association some time to get to this city. Grand Rapids — which we have not visited before — was selected as the site for our 2021 meeting. The 2020-2021 President, Rachel Stein, and the Program Committee that year had great things in store for our members until COVID-19 refused to lift its grip on us. For safety's sake, that gathering had to be moved online. Rachel and the team made our virtual meeting a success in its own right, but as 2022's conference in Indianapolis with President Fayyaz Hussain demonstrated, staring at a computer screen cannot impart as much of the inimitable good feeling that is produced when we can join colleagues and friends in person to share sociology and sociality. This is merely one meaning of the theme for this year's conference: "All Together Now."

I have invited a longstanding colleague of mine in the sociology of culture, Geneviève Zubrzycki of the University of Michigan at Ann Arbor, to deliver the Ruth and John Useem Plenary Address. Geneviève is the author of a series of award-winning books on religious and national identity. Her first, about post-Communist Poland, was *The Crosses of Auschwitz* (University of Chicago Press, 2006). This was followed by *Beheading the Saint* (University of Chicago Press, 2016), about her native Québec; and just last year by *Resurrecting the Jew* (Princeton University Press, 2022), about the revival of Judaism in Poland. Not only is Professor Zubrzycki a distinguished scholar, but she is a committed facilitator and organizer of research across intellectual boundaries and national borders, a topic that we ought to learn more about in her lecture, "International Sociology in the Age of Pandemic and War."

No NCSA president could accomplish a fraction of what is expected during his or her term without the often-unseen collaboration of many others in service to the association. While members rely on the regular appearance of opportunities to converge for discussions of teaching and research in the discipline, making such events happen actually requires a great deal of preparation, organization, and effort. 
We hope you are engaged, inspired, and stimulated by the sessions offered here. Enjoy the conference!

International Sociology in the Age of Pandemic and War

In her plenary, Dr. Geneviève Zubrzycki will discuss the specific challenges international sociology faces today and is likely to face in the years to come. While institutions of higher learning have all been affected by the global pandemic, border closures and travel bans have had a greater impact on some disciplines, fields, and approaches than on others. What is the future of field research, international collaboration, and international educational opportunities for our students? How can sociology rise to the occasion and offer answers to some of the world's most urgent questions?

Geneviève Zubrzycki is Professor of Sociology at the University of Michigan where she also directs Weiser Center for Europe and Eurasia and the Copernicus Center for Polish Studies. After receiving her Ph.D. from the University of Chicago (2002), she held a post-doctoral fellowship at UVA's Center on Religion and Democracy (2002-03). A comparative-historical and cultural sociologist, she has published widely on nationalism and religion; collective memory and national mythology; and the contested place of religious symbols in the public sphere. Zubrzycki is the author of the award-winning books *The Crosses of Auschwitz:* Nationalism and Religion in Post-Communist Poland (Chicago 2006, Polish trans. 2014) and Beheading the Saint: Nationalism, Religion and Secularism in Quebec (Chicago 2016, French and Polish trans. 2020), and the editor of National Matters: Materiality, Culture, and Nationalism (Stanford 2017). Her most recent monograph, Resurrecting the Jew: Nationalism, Philosemitism, and Poland's Jewish Revival was published in 2022.

In addition to her permanent position at the University of Michigan, she has held visiting appointments at the École des Hautes Études en Sciences Sociales in Paris and at the Netherlands Institute for Advanced Study in the Humanities and Social Sciences in Wassenar. Her research has been funded by the *National Science Foundation*, the *Woodrow Wilson National Fellowship Foundation*, the *MacArthur Foundation*, and the *Society for the Scientific Study of Religion*. In 2021, she was awarded a Guggenheim Fellowship and the Bronisław Malinowski Prize in the Social Sciences from the Polish Institute of Arts and Sciences of America.

Where Did Your Christ Come From? Exploring the Significance and the Prevalence of the White Jesus Phenomenon Among Black Protestant Women and Men.

Berger's theory of religion and world construction fails to consider the critical issue of power and who is allowed to construct their own reality and thus, does not adequately capture the experience of Black Christians and the Black religious experience. I use White Jesus as a case study to analyze this process. Though the White Jesus phenomenon has been more readily explored in theological and historical fields, very little sociological research discusses this phenomenon. I argue that a Europeanized Jesus has had harmful sociocultural effects on Black Christians and Black people, in the form of cultural trauma. Yet, the White Jesus phenomenon still persists in the Black Church. This study utilizes abductive analysis with 14 interviews and 1 focus group with Black Baptist women and men, finding that women tend to find the phenomenon less significant in their lives while men tended to be hypervigilant about the phenomenon and consider it more negatively impactful to the Black community. Many of the respondents who did not find the phenomenon significant tended to exhibit signs of kingdommindedness and colorblind ideology in their religious lives.
